Back Forty Kennel Boarding Agreement

Check In/Pick Up times are 7-8 a.m. or 4 - 5 p.m.

This is a Contract between Back Forty Kennel, LLC(hereinafter called "Kennel") and the pet owner whose signature appears below(hereinafter called "Owner") for services for _____hereinafter called "Pet").

1. Credit Card on file is required to schedule reservations. If a reservation is canceled more than 30 days before the reservation, there is no fee. Cancellation less than 30 days from the reservation the fee will be 50% of the total payment. If a reservation is canceled less than two weeks from schedule reservation or (Holiday weekends canceled less than 30 days from reservation), a total fee for reservation is due. Holiday schedules are the two weeks surround the holiday. All days reserved are responsible for payment.

2. By signing contracts and boarding pet, owner certifies to the accuracy of all information given about said pet to the best of their knowledge. Kennel shall exercise reasonable care for pet delivered by owner to kennel for boarding.

3. It is expressly agreed by the owner & kennel that kennel liability shall in no way exceed fair market value for pet boarded. Furthermore, the owner is solely responsible for any and all acts of said pet while under kennel care. The owner agrees to be financially responsible for any kennel or kennel supply damage. Reasonable costs for damage payable upon pet pick-up.

4. By signing, representation of pet ownership is specifically implied. By signing, the owner specifically represents that pet has not been exposed to Rabies, Distemper or Bordetella within a thirty(30 day period prior to boarding. Any dogs aggressive to other dogs or people are not allowed nor are dogs in heat cycle, accidental pregnancy is the responsibility of the owner.

5. In the event a pet becomes ill, gets injured, or displays behavior endangering itself, other dogs being boarded, or kennel staff, the kennel will immediately try to contact its owner. If the owner cannot be contacted, the kennel has sole discretion to engage the services of a licensed veterinarian. However, in extreme instances, licensed veterinarian care may be sought immediately before any owner contacts. In this instance, the owner agrees to allow veterinarian and veterinarian staff to administer any 'reasonable' care deemed necessary to correct the situation. The owner is solely responsible for any veterinarian charges.

6. Unless otherwise specified by the owner, kennel is authorized to use any/all pictures taken of pet while under kennel care. (Use implies website & any promotional materials.

7. Per the Minnesota 346.37 General Provisions, subdivision 1. Abandoned animals. Owner acknowledges that they have two(2) days to pick-up dog after any scheduled pick-up date. After two(2) days, certified mail will be sent to the owner stating balance owed to kennel and date in which owner must take possession. Full payment(including any accrued fees) is due upon pick-up of pet. If the pet is not picked up by stated date on certified letter, pet will be considered surrendered to and become property of Back Forty Kennel, LLC. Back Forty Kennel, LLC will then have sole discretion regarding pet care & ownership.

8. By signing, the owner acknowledges reading all terms of the Boarding Agreement and accepts all policies within. This contract contains the entire agreement between Back Forty Kennel, LLC and its owner.
